

You received an RL-5 slip and a T5007 slip for the 2024 taxation year.

Why?

- ✓ Because the CNESST paid you certain amounts (benefits) in 2024. **or** ✓ Because the CNESST reimbursed your employer directly for certain amounts paid to you. **or** ✓ Because you reimbursed the CNESST for certain amounts paid to you.

What must you do?

You must report the amounts that appear on the RL-5 slip (**box C, box E, box M or box P, as applicable**) and on the T5007 slip (**box 10**) on your provincial and federal tax returns. Although these amounts are not taxable, they may have a tax impact on your tax return. For example, the amount in box M – Adjustment for income replacement indemnities received for the RL-5 year – reduces your basic personal amount because it was included in the calculation of the indemnities paid to you by the CNESST (see line 358 of the provincial tax return guide).

It is also important to specify that the treatment of benefits paid by the CNESST may differ depending on the level of government. For example, compensation paid to a crime victim does not have to be declared to the federal government. Therefore, in this case, the provincial RL-5 slip may indicate an amount in box E while no amount appears on the federal T5007 slip.
